**Payment:** Adult tour admission is \$5 per person for groups of ten (10) or more, with tour leader and bus driver receiving complimentary admission. We require a 50% deposit for all group tours at time of booking to reserve the day and time of the program. Final payment will be due a minimum of seven (7) days before the program date, along with final number of attendees. If the number of guests increases within seven days of the program, we will be able to add them to the program for the designated fee. If fewer guests attend than projected, we will not be able to refund the fee.

Unfortunately in order to preserve the historic integrity of the Carlyle House, portions of the house are not wheel chair accessible and the use of stairs is necessary for the tour. If you have any questions regarding this, please feel free to contact us.

As you may be aware, there is no parking at Carlyle House, but there are several parking garages in the area, as well as on-street parking. Please ensure any transportation providers have this information.

Buses: All buses must register on the city website and park in one of 2 designated places. There are separate areas also designated for loading and unloading passengers. Although the parking permit requires a login, it is free to register, and you print your pass out online. **Alexandria City Motorcoach Website:** <u>http://alexandriava.gov/Motorcoach</u>

The closest passenger unloading area to Carlyle House is on Market Square: 300 block of King Street (5 spaces), north side, westbound, between Fairfax and Royal Street. The closest parking area to Carlyle House is Waterfront Parking: 500 Block of North Union Street (4 spaces) Between Oronoco and Pendleton Streets, east side, northbound: 3 hour parking.
