



Dear Parents,

Welcome to Camp Grow 2021! We have planned another amazing summer filled with fun and discovery here, at Meadowlark Botanical Gardens. Since most of the camp's activities are outdoor, we ask that your camper come every day with the following items (labelled with your child's name).

- Backpack
- Sun screen with bug repellent (Please apply each morning before camp.)
- Full and durable water bottle
- A lunch and a snack in a lunch bag/box. (Campers work up a big appetite.)
- Campers should wear sneakers. No open-toe or Croc style shoes allowed.
- An extra change of clothes in case campers get wet
- Raincoat if calling for rain
- A mask / face covering
- Other helpful items are a towel, hat, cooling towel (usually sold at Walmart, Target, Amazon), and a small, inexpensive, fold-up rain poncho to keep in the backpack. Some campers like to bring their own gardening gloves.

Details on daily pick up and drop off of campers will be provided in a separate communication closer to camp time. Please do not drop off or pick up your child without signing in/out with an ID. If your child is going to be late, absent or has to leave early, please call 703-255-3631 x103, or the number(s) provided to you by your camp counselors.

NOVA Parks has developed protocols and standards related to the COVID-19 pandemic that all participants are expected to follow. This includes but is not limited to frequent cleaning/sanitizing, social distancing and mask wearing, and temperature checks. Please note that to ensure proper social distancing, there will be no camp field trips at any Camp Grow 2021 camp session.

Please make certain that you go over of camp rules in this packet with your child and read the information thoroughly. All camp forms should be submitted at least two weeks before the first day of camp. The staff at Meadowlark Botanical Gardens wants every child who participates in our Summer Camp to have a safe and enjoyable experience.

# Camp NOVA Roov

## **Camp Policies**

Welcome to summer camp at Meadowlark Botanical Gardens' Camp Grow. Our goal is to provide campers with a safe and enjoyable camp experience where they can develop skills, form friendships, and enhance self-esteem.

### **REQUIRED CAMP FORMS**

All forms in the Camp Grow packet must be submitted prior to the start of camp. Submitting forms at least two weeks in advance is requested.

### ADMINISTERING MEDICATION

NOVA Parks staff is not permitted to administer medication to children while participating in our camp program with the exception of autoinjectors if a child is not able to administer it himself/herself.

### SYMPTOMS OF ILLNESS

If a child arrives with symptoms of illness or has a temperature over 100 degrees, the child will not be permitted to stay. If a camper starts exhibiting symptoms of illness at camp, parents will be required to pick up their child immediately. Sites will notify all parents about disease outbreaks or infections. Camp management will consult with parents on when children may return.

### DAILY SIGNING IN/OUT

Morning drop off/sign in is between 8:45 and 9:00 a.m. Pick up/sign out is from 4:00 to 4:15 p.m. for full-day camps and 1:00 to 1:15 p.m. for halfday camps. Authorized individuals 18 years or older must sign campers in and out each day. Staff is required to I.D. all persons picking up campers. Children will not be released to anyone not on the Pick-Up Authorization Form. Be sure to include parents on the Pick-Up Authorization Form. If your child will be late, absent or leave early, please call 703-255-3631 x0 or email <u>imaloney@nvrpa.org</u>.

### LATE PARENT POLICY

If a parent or authorized person is late picking the camper, a late fee of \$2 for each minute beyond 15 minutes late will be assessed. A staff member will remain with children and, after one hour, Child Protective Services may be called.

**PLEASE LABEL ALL BELONGINGS.** Camper should not bring electronics and toys to camp. NOVA Parks and camp staff are not responsible for campers' belongings.

#### **BEHAVIOR MANAGEMENT**

If a camper brings a weapon to camp, intentionally harms others, vandalizes property, or displays other such behavior, he/she will be dismissed from camp and no refund will be given. NOVA Parks reserves the right to immediately dismiss a child from any program.

**Staff will never** use physical punishment, be verbally abusive, force, withhold or substitute food, give any child the authority to punish another child, place a child out of visual/hearing sight, in the dark, or in an unvented place, or punish a child for a bathroom accident. **CANCELLATIONS &** 

### REFUNDS

There are no refunds for missed days due to changed work/vacation schedules or sick days. Refunds minus a \$25 administrative fee (when cancelling an entire camp registration only) will be provided for cancellations made at least 45 days prior to the first day of the camp session.

FOOD FROM HOME Each camper must bring his/her own lunch from home every day and may not share food with others.

#### SUNSCREEN & LOTION APPLICATION

Staff is not permitted to apply sunscreen or lotion on campers, although staff can guide campers in these applications.

#### WEATHER

Park facilities allow NOVA Parks Day Camps to operate rain or shine. Camp activities are scheduled and modified with weather and summer heat in mind and include regular water and cool down breaks. Water is available for campers to refill their water bottles. On code red days, camp activities are modified accordingly – safety is the priority.

#### **REPORTING CHILD ABUSE & NEGLECT**

Under Code of Virginia (63.2-1509), staff is required to report any suspected abuse, neglect, or exploitation of a child to NOVA Parks management and Child Protective Services.

### QUESTIONS/CONCERNS/ADDITIONAL CAMPER INFORMATION

Parents are encouraged to provide the Program Manager with information about their campers that could assist camp staff in working effectively with their child (for example: developmental challenges, services that are provided at school, significant shyness, or if the camper will be accompanied by an aide).



# **Camp Grow Rules of Conduct**

### This document is a requirement for camp enrollment.

### Children must:

- Wear masks and observe social distance guidelines at all times
- Maintain personal care (portable restroom use, changing) without staff support
- Stay with assigned group at all times
- Listen to program leaders and follow directions
- Keep hands to oneself and maintain self-control
- Use appropriate language and respect others in what you say and do
- Take care of their own belongings
- Use equipment and supplies in a safe and appropriate manner
- Respect others in what you say and do
- Remain seated during lunch and snack and keep their food to themselves (no sharing of food or drink)
- Teasing and bullying are not tolerated and are grounds for enrollment termination. Children should report these incidents immediately to their counselor.
- Play safely and have fun

### Parents must:

- Wear masks and observe social distancing guidelines at all times
- Complete and submit appropriate paperwork from the parent packet
- Sign children in and out of the program and bring proper photo I.D. each day
- Be on time to drop off and pick up children
- Assist staff in resolving behavior issues
- Contact the Camp Management immediately should issues arise.

### Grounds for Immediate Dismissal (no refund given):

- A parent or child who refuses to follow mask wearing and social distancing guidelines
- A parent who refuses to follow NOVA Parks policies as stated in this packet
- A child who brings a weapon to camp
- A child who intentionally harms himself/herself or causes injury to another child or staff member
- A child who vandalizes the property of the camp facility, staff or other children
- A child who steals items from the camp facility, staff or other children
- A child teasing and/or bullying others
- A child who displays inappropriate behaviors repeatedly
